To: Buyers of Warm Season Sod

Re: Georgia Certified Turfgrass

Over the last few years and driven by the rebounding economy, Georgia has seen an increase in sod farms and individuals brokering sod. As I am sure you are aware, sod quality and purity vary greatly from farm to farm based on management and the original source of planting stock. Unfortunately, only about half of the sod farms in Georgia participate in the GCIA Turfgrass Certification Program which is a third party inspection service aimed at ensuring genetic purity and freedom from noxious weeds. As a result, we have recently received numerous reports of contaminated, non-certified sod being purchased and installed on projects around the state. On the next page, I have included a photo of one such instance for your reference.

The only way to ensure that you are receiving sod of the highest quality and purity is to purchase GCIA Blue Tag Certified Sod. A list of participating growers can be found in the GCIA Turfgrass Buyers Guide on our website – [www.georgiacrop.com](http://www.georgiacrop.com). In particular, every shipment of certified sod must be accompanied by a GCIA Turfgrass Certificate; I have included a sample on the next page. This certificate documents that the sod purchased was produced on a certified and inspected farm.

Also worthy of note, we have heard of instances of non-certified sod being misrepresented as certified sod. Please be aware that the Georgia Department of Agriculture's Live Plant Certificate is NOT equivalent to the GCIA Blue Tag Certificate. The Live Plant Certificate is indicative of apparent freedom from weeds, pests and diseases and NOT an indication of purity or quality.
