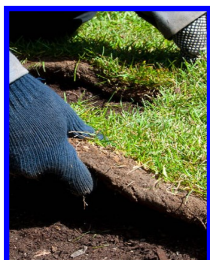
GCIA President Jutt Howard reflects on Terry Hollifield's years of service

2023 Acres Applied For:

CROP	ACRES
Peanuts	138,342
Turfgrass	9,890
Small Grains	5,012
Forage Grasses	1,201
Soybeans (including Corteva)	5,700

PEANUTS:

Acres up 12k compared to 126K acres in 2022. Field inspections were conducted in August & September with four fulltime staff & three part-time inspectors. The Annual buying point training was held on August 28th in Albany.

TURFGRASS:

Turfgrass acres held steady at 9,890 acres applied for this year. 3rd round of turf inspections were conducted in September & October.

SMALL GRAINS & BAHIA GRASS:

5,012 small grain acres this year which is up 1,000 over 2022; forage grass acres ticked up slightly to 1,200.

SOYBEANS:

Approximately 5,700 acres of soybeans will be inspected this year which would be 1,000 acres over 2022 with the majority of the acres being contract inspections for Corteva.
