## UGA's Wayne Parrott Named AAAS Fellow By: Allyson Mann, UGA CAES



University of Georgia Professor of crop and soil sciences Wayne Allen Parrott has been named a Fellow of the American Association for the Advancement of Science, an honor bestowed by his peers for "scientifically or socially distinguished efforts to advance science or its applications." Parrott is among 396 new AAAS Fellows who will be presented with an official certificate and a gold and blue - representing science and engineering, respectively - rosette pin at the AAAS Fellows Forum during the 2018 AAAS Annual Meeting in Austin, Texas.

Wayne Parrott, professor of crop and soil sciences at the University of Georgia, believes that genetically improved plants will help feed the world, and he's traveled the globe to help connect farmers and scientists with what they need to make that happen. Since coming to UGA in 1988, Parrott's laboratory has served as an international flagship for genetic research in soybeans and other crops. He's spent the last three decades not only developing new soybean varieties and researching the human and environmental safety of genetically modified crops.

"Selection as an AAAS Fellow is a major milestone in a scientist's career, and thus the University of Georgia is enormously pleased that three of our faculty have been selected for this honor," said David Lee, UGA vice president for research. "This peer recognition is important to our faculty, and it also brings added distinction to the university."

Parrott, a member of the UGA College of Agricultural and Environmental Sciences faculty, is honored for his distinguished contributions to the development and implementation of plant transformation technologies and to the discussions of the science and regulatory processes associated with genetically modified organisms.

For nearly 30 years, he has conducted research on the discovery, evaluation and use of agriculturally important genes in crop plants, using both molecular markers and genetic engineering, especially in soybean and switchgrass. His emphasis is on developing the methodology for use and safety assessment of genetically modified crop plants, and he has published a guide for environmental risk assessment of GMOs.

## **Remembering former GCIA board member Charles Carter**

It is with great sadness that we report the passing of Charles Wilmer Carter on November 16, 2017. Mr. Carter was a proud World War II veteran having served in the Philippines. While a proud veteran, his life's work and passion was managing his 650 acre cattle and row crop farm in Winterville, Georgia. He was among the first to have a GCIA Approved Seed Conditioning Facility and served on the GCIA Board of Directors for several terms in the 1970's.

Mr. Carter was always a leader, serving as Commissioner for the Athens-Clarke County Unified government and several agricultural organizations, including the Board of the Northeast Georgia Cattle Barn, Clarke County Farm Bureau, Clarke -Oconee Cattlemen's Association and Northeast Georgia Resource Conservation and Development Council. At the time of his death, he was a member of American Legion Post 20, Tuckston United Methodist Church, and the Clarke County Farmers Roundtable.


